B. Consider review and approval of the Measure V V Financial Statement and the adoption of <u>Resolution No. 11-1</u> determining that the Measure V V funds collected during the 2010-11 fiscal year have been appropriated and expended in Special Transit Service District One for operation and maintenance activities (CFO Memo No. 11-01).

Chief Financial Officer Lewis Clinton presented the staff report and addressed questions from the committee.

The Committee requested that future reports include a signed copy of the audit and that the name of the firm performing the audit appear on the document. It was further noted for the record that Maze & Associates had performed the audit of the FY 2010-11 Measure V V funds.

Discussion ensued regarding funding for Special Transit Service Districts One and Two, including the list of expenses provided in the report and the appearance of a service increase in Special District Two. In addition, the Committee expressed a desire to review the allocation methodology for both Districts in order to have a better understanding of how Measure V V funds factor into service and operations in District One.

In addition, the Committee expressed a desire to have more information in front of it pertaining to other revenues received by the two Districts as well as the audited financial statements for the entire District and the ballot language pertaining to the role of the Committee. Member Abelson suggested that in addition to expenses, the 2012 report should include a table outlining the revenue sources for both Districts.

Member DeRoo expressed concern with the notion of certifying that the Measure V V funds were applied for the purposes intended without looking at the bigger budgetary picture. She added that future meetings needed to allow more time for a broader discussion in this regard.

The Committee requested that the following information be provided after the meeting:

- AC Transit Audited Financial Statements for the FY Ended June 30, 2011;
- AC Transit FY 2011-12 and 2012-13 Biennial Operating and Capital Budget;
- Resolution placing Measure V V on the ballot (Resolution No. 08-044); and
- Resolution appointing the membership of the Committee (Resolution No. 08-064).

[The items were forwarded by email to the Committee Members immediately following the meeting by the District Secretary. Staff is to provide at all subsequent meetings copies of the annual District audit, ballot measure language and the resolution establishing the Committee and appointing its membership.]

She further inquired about the process to appoint additional members when vacancies occur and whether the Committee had any administrative procedures, and if so, requested that a copy be distributed to the members. The District Secretary reported that the Board of Directors would receive an update in January on the status of the Committee and discuss the recruitment of new committee members. She further reported that the resolution appointing the membership of the Committee did provide some guidance as to administrative procedures and that she would forward a copy to the Committee for review.

Member Viramontes apologized for not being able to attend past meetings.

There being no further business to come before the Committee, the meeting adjourned at 3:26 p.m. The next meeting of the District Parcel Tax Fiscal Oversight Committee is scheduled for December 2012.
