AGENDA PLANNING REQUEST:

RECOMMENDED ACTION(S):

Hold Public Hearing to receive comment on the introduction of two proposed Ordinances (Ordinance 20 (Evergreen) and Ordinance 20 (Jade)) establishing a seven-ward election system and sequence of elections pursuant to Elections Code Section 10010; and introduce and waive the reading of the ordinances.

STRATEGIC IMPORTANCE:

Goal - Strong Public and Policymaker Support Initiative - Internal and External Diversity, Equity, Inclusion and Accessibility Programs and Priorities

BUDGETARY/FISCAL IMPACT:

If either of the ordinances is adopted, it will save AC Transit approximately \$2.5 million in at-large election costs for the 2024 and 2026 election cycles based on 2022 figures. This does not include any additional savings that will result from reducing the size of each ward, which will have fewer voters.

BACKGROUND/RATIONALE:

On July 27, 2023, the Board of Directors adopted Resolution No. 23-033 declaring its intent to transition from hybrid ward-based and at-large elections to solely ward-based elections, to initiate procedures, and implement ward-based elections for at-large members of the Board of Directors.

On September 6 and September 13, 2023, the Board of Directors held the first and second of five public hearings required to transition AC Transit's Board elections to a seven-ward election system. Public hearings #1 and #2 were held prior to any draft maps being drawn and covered the public input process and the composition of the new voting wards prior to the drawing of any draft maps. At its September 13 hearing, the Board provided direction to begin drawing draft maps for a seven-ward election system. Based on public input and Board feedback, the District's demographer prepared six redistricting plans for review: Green, Blue,

Purple, Red, Orange, and Yellow. These plans were made publicly available on September 25, 2023, as were the plans submitted by the public by the September 20th deadline. Community of Interest submissions received through the online DistrictR mapping tool were also provided.

At Public Hearing #3 held on October 4, 2023, the Board received an in-depth overview of the six draft redistricting plans and discussed their preferences regarding the plans and the sequencing of elections. After considering all the plans, there was consensus to direct the demographer to:

- Number the wards 1 through 7, north to south for all variations of the plans presented at the next meeting;
- Address questions about sequencing at the next meeting in terms of which wards will come up for election in 2024 versus 2026;
- Renumber the Green Plan as described above;
- Prepare a variation of the Green Plan that includes Wards 1 through 5, and Wards 6 and 7 from the Red Plan; and
- Prepare a variation of the Green Plan that splits the downtown area of Oakland into at least two and
 up to three wards and has flexibility as to potentially rotating through Emeryville/the Oakland Hills
 while maintaining the community of interest in East Oakland.

On October 25, 2023, the Board held Public Hearing #4. An updated set of draft maps (referenced as Pine, Apple, Emerald and Lemon), was prepared for review and discussion. Also discussed at length was the sequencing of future elections associated with each map. After a lengthy discussion, there was consensus to move forward with Plan Pine as presented and an amended Plan Emerald moving:

- 1. Bushrod neighborhood in Oakland to Ward 2
- 2. Remaining portions of Downtown Oakland east of Broadway to Ward 3
- 3. Glenview neighborhood in Oakland to Ward 4
- 4. Cherryland to Ward 5
- 5. Fairview to Ward 6

In addition, the Board authorized the District Secretary to make technical, non-substantive corrections and to correct a minor external boundary adjustment in Ward 6 (previously Ward 4). The resulting prepared plans are named Plan Evergreen (previously Pine) and Plan Jade (amended Emerald).

The Board gave final direction to prepare ordinances for the November 8th public hearing as follows:

- Draft an Ordinance for Plan Evergreen with two sequencing options: 1) prioritizing wards 1, 6 and 7 for the 2024 election cycle, and 2) prioritizing wards 1, 2 and 6 for the 2024 election cycle.
- Draft an Ordinance for Plan Jade with two sequencing options: 1) prioritizing wards 1, 6 and 7 for the 2024 election cycle, and 2) prioritizing wards 1, 2 and 6 for the 2024 election cycle.

There was consensus that the proposed ordinances be presented for public comment at the November 8th public hearing with the selection and adoption of one of the two ordinances to occur on December 13, 2023.

Public Hearing #5

In accordance with the Board's direction given at the October 25, 2023 public hearing, staff submits two ordinances for final comment from the public. The revised map for Plan Emerald (now Plan Evergreen) and the map for Plan Jade were published seven days prior to the hearing. Following the close of the public hearing, the Board is requested to introduce and waive the reading of <u>both</u> proposed Ordinances. A final decision to adopt an ordinance is expected at the December 13, 2023, Board meeting.

With respect to ordinances, Board Policy 101, Section 6.8, Board of Directors Rules for Procedure, provides:

"Unless otherwise requested by a Director, it shall be unnecessary for the District Secretary to read aloud more than the title of a written ordinance submitted to the Board for action. No ordinance shall be passed by the Board on the day of its introduction nor within three (3) days thereafter, nor at any time other than at a regular or adjourned-regular meeting.

Following action adopting an ordinance, the ordinances shall be signed by the Board President. Each ordinance shall include a certification by the General Counsel approving the document as to form and content and a certification by the District Secretary specifying the date of adoption and roll call vote adopting the ordinance.

All ordinances shall be published after passage once a week for two consecutive weeks. Ordinances shall become effective thirty (30) days from the date of final passage."

Election Sequencing

The issue of election sequencing is a complicated topic. As noted in the demographer's presentation at hearings #3 and #4, it is unusually complicated for AC Transit as the District is dealing with two different legal issues: transitioning from a five to seven-member board [California Voting Rights Act- CVRA] and redistricting [deferral, meaning that some voters must wait six years to vote for their ward representative] at the same time.

After the 2024 election, the Board will be made up of seven seats. Four of those will come from those seats elected in 2022. Because the law prohibits cutting short the term of any of these members, the following seats will remain the same until they are up in 2026:

- * At Large (Young)
- * Old 3 (Syed)
- * Old 4 (McCalley)
- * Old 5 (Shaw)

If the person (listed above) representing one of those seats were to vacate that seat, the seat would be filled based on the old lines.

After the 2024 election, in addition to the aforementioned four seats, the Board will have three seats elected in 2024 under the new lines. Thus, during the transitionary period from 2024 to 2026, the Board will continue to be constituted of seven members: 4 old + 3 new = 7.

For example, if the new Ward 2 does not vote in 2024, as under sequencing Option 1, the Board would not end up with 6 Directors. Rather, it would be made up of 4 members elected under the old lines (At Large, Old 3, Old 4, Old 5) plus three under the new (New 1, New 6, New 7). Similarly, no such sequencing scenario would result in expanding the Board to eight. Pub. Util. Code, section 24801 requires a seven-person board. Public Utilities Code section 24862 would not allow for a fourth ward to vote in 2024.

The result of these sequencing issues is that between 2024 and 2026, some people will end up with two-ward elected representatives (excluding the at-large seat), and some will end up with no-ward elected representatives but will have an at-large representative for whom they were able to vote in 2022. The former is ACCELERATION: People who vote in both 2022 and 2024 for a ward will end up with two representatives. The latter is DEFERRAL: People who voted in 2020 and then not again until 2026 would not have a ward-based representative for two years but would still have an at-large representative.

Deferral and acceleration do impact questions of fair and equal representation. As a result, the courts have said minimizing deferral is something that can legitimately be considered in determining the sequence of elections. However, some degree of acceleration and deferral is an inherent part of the redistricting process and usually unavoidable. Importantly, this is a temporary situation that will be corrected in 2026.

Some jurisdictions choose to designate a member of the Board to serve as a contact and provide services to persons in deferred areas during this transitionary period. The District will also continue to have one at large member representing the entire jurisdiction through 2026.

As an example, under both plans, and both sequencing options, some people in the Old Ward 2 are moved into the New Ward 4 and as a result would be deferred. This was done for a legitimate policy purpose, primarily to unite a previously divided community of interest (Fruitvale). The example shows why the mere existence of deferral has not been found to create a violation of fair and equal representation principles. Rather, it is just one of many factors that has to be considered in the process.

In the case of AC Transit, one of those additional factors the California Voting Rights Act, and its specific requirement that in considering sequencing, "the governing body shall give special consideration to the purposes of the [CVRA], and it shall take into account the preferences expressed by members of the districts." (Elec. Code, section 10010(b)).

Attachment 4 provides a breakdown under both plans and both sequencing options of persons deferred and accelerated. Counsel will be prepared to address any lingering questions about election sequencing at the meeting. A letter from the CVRA plaintiffs' counsel concerning election sequencing is provided in Attachment 5 for the Board's consideration.

Community Outreach

Community outreach throughout the redistricting process has been robust and has provided the public with several opportunities to participate in the process. At this juncture, six workshops have been held to educate the public about the process, instruct on how to use the tools available to draw maps and solicit feedback on the various redistricting plans. Please reference Staff Report 23-391b for more information about the public outreach plan for the restricting process.

ADVANTAGES/DISADVANTAGES:

A significant advantage of adopting an ordinance is the substantial savings to the District in the cost of administering elections for seats on the Board of Directors. Another important outcome would be the implementation of an election system that addresses the concerns raised in the CVRA demand letter received by the District in March.

ALTERNATIVES ANALYSIS:

The process to transition to a seven-ward election system is set forth in statute; therefore, there are no practical alternatives to the course of action outlined in this report.

ALAMEDA-CONTRA COSTA TRANSIT DISTRICT ORDINANCE NO. 20 (EVERGREEN)

AN ORDINANCE TO ESTABLISH A SEVEN-WARD SYSTEM FOR ELECTING DIRECTORS TO THE ALAMEDA-CONTRA COSTA TRANSIT DISTRICT BOARD OF DIRECTORS

WHEREAS, the Alameda-Contra Costa District ("District") is duly organized as a special district and operates as a rapid transit district, politically created pursuant to Transit District Law (Division 10 of the Public Utilities Code of the State of California) by the electorate on November 6, 1956; and

WHEREAS, on March 27, 2023, the District received a letter from lawyers alleging that the District's method of electing two of the seven members of the District's Board of Directors in at-large elections instead of by-ward elections violates the California Voting Rights Act ("CVRA"), Elections Code section 14025 et seq.; and

WHEREAS, on July 26, 2023, the District's Board of Directors adopted Resolution No. 23-033 pursuant to Elections Code sections 10650 and 10508, declaring its intent to transition from a hybrid at-large and by-ward election system to a solely by-ward election system commencing with the November 2024 General Election, using 2020 Census data, demographic study, and community feedback. This resolution established specific steps to undertake and facilitate this transition; and

WHEREAS, pursuant to Elections Code section 10010, and the timeframes set forth in the statute, the District took the following actions:

- (a) Conducted public outreach, including to non-English speaking communities, to explain the redistricting process and to encourage public participation;
- (b) Before drawing a draft map or maps of the proposed ward boundaries, held at least two (2) public hearings over a period of no more than 30 days, at which the public was invited to provide input regarding the composition of the wards and to consider ward boundaries as provided in Elections Code section 10010;
- (c) After drawing a draft map or maps, published the draft map(s) and the potential sequence of the ward elections and held at least two (2) public hearings at which the public was invited to provide input regarding the content of the draft map(s) and the proposed sequence of elections. The first version of a draft map was published at least seven days before the third public hearing. Revised draft maps were published and made available to the public for at least seven days before the fourth public hearing at which they were considered; and
- (d) Held a public hearing at which the Board of Directors considered Ordinances establishing by-ward elections, including proposed ward boundary maps and sequences of the ward elections; and

WHEREAS, the District conducted robust public outreach related to redistricting, including six multi-lingual workshops, including four virtual and two held in person; outreach to community-based organizations, elected officials and members of the public; display ads published in Spanish and Chinese newspapers; multi-lingual ad cards placed on buses advertising the public hearings and workshops; regular social media posts and press releases; and a dedicated redistricting webpage (actransit.org/redistricting); and

WHEREAS, multi-lingual workshops were held on September 7 and September 11 at which the public received information about the redistricting process, communities of interest, and the use of available tools to create and submit maps for consideration by the September 20, 2023 deadline. Additional workshops were held on September 30, October 12, and October 17, 2023 to review draft maps and provide input on the design of the wards and sequencing of elections; and

WHEREAS, the District tailored all communications regarding redistricting to its constituents in the three predominant languages spoken in the District's service area (English, Spanish, and Chinese), including all public hearing notices, staff reports, maps, presentations, and redistricting information. Spanish, Mandarin, and Cantonese interpreters were provided at every workshop and public hearing; and

WHEREAS, before any maps of the proposed boundaries of the wards were drawn, the Board of Directors (Board) held two (2) public hearings on September 6, 2023 and September 13, 2023, respectively, at which time input from the public on the composition of the District wards including criteria for determining ward boundaries was invited and heard; and

WHEREAS, at the public hearings on September 6, 2023 and September 13, 2023, the Board considered all oral and written information, testimony, and comments received during the public review process, including information received at the public hearings and workshops, oral and written reports from District staff and the District's demographer, and all pertinent information prior to acting on, or making recommendations on, the ward election process and composition of maps; and

WHEREAS, at the public hearing on September 13, 2023, the Board provided initial direction to the demographer to begin drawing draft maps for a seven-ward election system; and

WHEREAS, based on public input and Board feedback, the District's demographer prepared six redistricting plans for review: Green, Blue, Purple, Red, Orange, and Yellow. These plans were made publicly available on the District's website on September 25, 2023, and the public was invited to comment on the plans as well as on the plans submitted by the public by the September 20, 2023 deadline; and

WHEREAS, at the public hearing on October 4, 2023, the Board considered all oral and written information, testimony, and comments received during the public review process, including information received at the public hearings and workshops, oral and written reports

from District staff and the District's demographer, maps, and all pertinent information prior to acting on, or making recommendations on, the content of the draft maps and the proposed timing and sequence of elections; and

WHEREAS, at the public hearing on October 4, 2023, the Board instructed its demographer to number the wards 1 through 7, north to south for all variations of the plans presented at the next meeting; address questions about sequencing at the next meeting in terms of which wards will come up for election in 2024 versus 2026; renumber the Green Plan as described above; prepare a variation of the Green Plan that includes Wards 1 through 5 and Wards 6 and 7 from the Red Plan; and prepare a variation of the Green Plan that splits the downtown area of Oakland into at least two and up to three wards and has flexibility as to potentially rotating through Emeryville/the Oakland Hills while maintaining the community of interest in East Oakland; and

WHEREAS, on October 16, 2023, consistent with the provisions of California Elections Code Section 10010, the District made publicly available on its website for review and comment an updated set of draft maps, respectively entitled, Pine, Apple, Emerald and Lemon; and

WHEREAS, at the public hearing on October 25, 2023, the Board considered all oral and written information, testimony, and comments received during the public review process, including information received at the public hearings and workshops, oral and written reports from District staff and the District's demographer, maps, and all pertinent information prior to acting on, or making recommendations on, the content of the draft maps and the proposed timing and sequence of elections; and

WHEREAS, at the public hearing on October 25, 2023, the Board of Directors directed the preparation of two ordinances for public comment and future consideration at the November 8, 2023 public hearing: one for the Pine Plan with two election sequencing options (one prioritizing Wards 1, 6 and 7 for the 2024 election, and another option prioritizing Wards 1, 2 and 6 for the 2024 election); and a second ordinance for the Revised Emerald Plan with two election sequencing options (one prioritizing Wards 1, 6 and 7 for the 2024 election, and another option prioritizing Wards 1, 2 and 6 for the 2024 election). In addition, the ordinances were to include language authorizing staff to make technical, non-substantive corrections and to correct a minor external boundary adjustment in Ward 4; and

WHEREAS, on October 27, 2023, consistent with the provisions of California Elections Code Section 10010, the District made publicly available on its website for review and comment updated draft maps, respectively entitled, Evergreen and Jade; and

WHEREAS, on November 8, 2023, the Board held its fifth and final public hearing, received public comment on two proposed ordinances (Ordinance 20 (Evergreen) and Ordinance 20 (Jade)), and introduced and waived reading of both ordinances; and

WHEREAS, the purpose of this Ordinance is to enact, pursuant to California Elections Code Section 10010, an ordinance providing for the election of Directors of the Board of

Directors of the Alameda-Contra Costa Transit District by-ward in seven wards to be created hereby.

NOW, THEREFORE, BE IT ENACTED BY THE BOARD OF DIRECTORS OF THE ALAMEDA-CONTRA COSTA TRANSIT DISTRICT:

<u>Section 1.</u> PURPOSE AND AUTHORITY.

The purpose of this Ordinance is to enact, pursuant to California Elections Code Section 10010, an ordinance providing for the election of members of the Board of Directors of the Alameda-Contra Costa Transit District by seven (7) single member wards. This Ordinance is adopted pursuant to the District's authority under California Elections Code Sections 10010, 10508, 10650 and Public Utilities Code Section 24823. The change in the method of electing members of the legislative body is being made in furtherance of the purposes of the California Voting Rights Act of 2001 (Chapter 1.5, commencing with Section 14025 of Division 14 of the California Elections Code).

Section 2. EFFECT OF ORDINANCE.

This Ordinance shall take effect thirty (30) days following its passage and adoption, and the text of the Ordinance (excluding exhibits which shall be made available at www.actransit.org/redistricting) shall be published after passage once a week for two consecutive weeks in a newspaper of general circulation within the Alameda-Contra Costa Transit District, with at least five days intervening between the respective publication dates not counting such publication dates.

Section 3. BY-WARD ELECTORAL SYSTEM FOR SEVEN DIRECTORS.

- (a) Pursuant to California Elections Code Sections 10010, 10508, and 10650, Directors shall be elected by-ward in seven (7) wards.
- (b) Except as provided in subdivision (c) hereof, the Director elected to represent a ward must live in that ward and be a registered voter in that ward, and any candidate for Director must live in, and be a registered voter in, the ward in which he or she seeks election at the time nomination papers are issued.
- (c) A Director in office at the time this ordinance takes effect shall continue in office until the expiration of the full term to which he or she was elected or appointed and until his or her successor is qualified. If vacancies in Director offices elected by-ward or at-large occur before the expiration of the full term thereof, such vacancies shall be filled according to law from the prior ward boundaries or District at-large, respectively.
- (d) Upon expiration of the full term of each Director elected at-large or by ward, that Director's successor shall be elected only on a by-ward basis in the wards established by this Ordinance. A vacancy in a Director office elected or appointed by-ward shall be filled according to law by a person qualified to hold the office, who lives, and is a registered voter, in the ward.

Section 4. WARDS.

Elections shall take place, and Directors shall be elected by wards, meaning one member of the ward shall be elected from each ward, by the voters of that ward alone. A copy of the adopted ward map and the metes and bounds for each of the seven wards are attached hereto as Exhibits A and B and are incorporated by reference.

Section 5. ELECTION SCHEDULE (OPTION 1)

- (a) Directors from Wards 1, 6 and 7 as so constituted shall be elected by ward beginning with the Statewide General Election in November 2024, and every four years thereafter.
- (b) Directors from Wards 2, 3, 4 and 5 as so constituted shall be elected by ward beginning at the Statewide General Election in November 2026, and every four years thereafter.

Section 5. ELECTION SCHEDULE (OPTION 2)

- (a) Directors from Wards 1, 2 and 6 as so constituted shall be elected by ward beginning with the Statewide General Election in November 2024, and every four years thereafter.
- (b) Directors from Wards 3, 4, 5 and 7 as so constituted shall be elected by ward beginning at the Statewide General Election in November 2026, and every four years thereafter.

Section 6. SEVERABILITY

If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held by a court of competent jurisdiction to be invalid, such a decision shall not affect the validity of the remaining portions of this Ordinance. The Board of Directors of the Alameda-Contra Costa Transit District hereby declares that it would have passed this Ordinance and each section or subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared invalid.

Section 7. MINOR CORRECTIONS

In case of an apparent conflict between the ward map attached to this Ordinance as Exhibit A and the ward metes and bounds in Exhibit B of this Ordinance, the ward map shall govern. The District Secretary is authorized to make technical adjustments to the ward boundaries specified in this section if necessary to facilitate the implementation of this Ordinance, so long as such adjustments do not materially affect the ward populations, the eligibility of ward candidates, or the residency of elected officials within any ward.



EVERGREEN PLAN

The ward areas are as follows:

Ward 1: All the portion of Alameda-Contra Costa Transit District lying northerly of the following line: Beginning at the intersection of the easterly boundary of the Alameda-Contra Costa Transit District and the northerly boundary of the County of Alameda, and proceeding westerly along the boundary of the County of Alameda to the northeasterly boundary of the City of Albany, and proceeding southerly along the boundary of the City of Albany to intersection of the boundary of the City of Albany and the westerly boundary of the Alameda-Contra Costa Transit District.

ALAMEDA-CONTRA COSTA TRANSIT DISTRICT ORDINANCE NO. 20 (JADE)

AN ORDINANCE TO ESTABLISH A SEVEN-WARD SYSTEM FOR ELECTING DIRECTORS TO THE ALAMEDA-CONTRA COSTA TRANSIT DISTRICT BOARD OF DIRECTORS

WHEREAS, the Alameda-Contra Costa District ("District") is duly organized as a special district and operates as a rapid transit district, politically created pursuant to Transit District Law (Division 10 of the Public Utilities Code of the State of California) by the electorate on November 6, 1956; and

WHEREAS, on March 27, 2023, the District received a letter from lawyers alleging that the District's method of electing two of the seven members of the District's Board of Directors in at-large elections instead of by-ward elections violates the California Voting Rights Act ("CVRA"), Elections Code section 14025 et seq.; and

WHEREAS, on July 26, 2023, the District's Board of Directors adopted Resolution No. 23-033 pursuant to Elections Code sections 10650 and 10508, declaring its intent to transition from a hybrid at-large and by-ward election system to a solely by-ward election system commencing with the November 2024 General Election, using 2020 Census data, demographic study, and community feedback. This resolution established specific steps to undertake and facilitate this transition; and

WHEREAS, pursuant to Elections Code section 10010, and the timeframes set forth in the statute, the District took the following actions:

- (a) Conducted public outreach, including to non-English speaking communities, to explain the redistricting process and to encourage public participation;
- (b) Before drawing a draft map or maps of the proposed ward boundaries, held at least two (2) public hearings over a period of no more than 30 days, at which the public was invited to provide input regarding the composition of the wards and to consider ward boundaries as provided in Elections Code section 10010;
- (c) After drawing a draft map or maps, published the draft map(s) and the potential sequence of the ward elections and held at least two (2) public hearings at which the public was invited to provide input regarding the content of the draft map(s) and the proposed sequence of elections. The first version of a draft map was published at least seven days before the third public hearing. Revised draft maps were published and made available to the public for at least seven days before the fourth public hearing at which they were considered; and
- (d) Held a public hearing at which the Board of Directors considered Ordinances establishing by-ward elections, including proposed ward boundary maps and sequences of the ward elections; and

WHEREAS, the District conducted robust public outreach related to redistricting, including six multi-lingual workshops, including four virtual and two held in person; outreach to community-based organizations, elected officials and members of the public; display ads published in Spanish and Chinese newspapers; multi-lingual ad cards placed on buses advertising the public hearings and workshops; regular social media posts and press releases; and a dedicated redistricting webpage (actransit.org/redistricting); and

WHEREAS, multi-lingual workshops were held on September 7 and September 11 at which the public received information about the redistricting process, communities of interest, and the use of available tools to create and submit maps for consideration by the September 20, 2023 deadline. Additional workshops were held on September 30, October 12, and October 17, 2023 to review draft maps and provide input on the design of the wards and sequencing of elections; and

WHEREAS, the District tailored all communications regarding redistricting to its constituents in the three predominant languages spoken in the District's service area (English, Spanish, and Chinese), including all public hearing notices, staff reports, maps, presentations, and redistricting information. Spanish, Mandarin, and Cantonese interpreters were provided at every workshop and public hearing; and

WHEREAS, before any maps of the proposed boundaries of the wards were drawn, the Board of Directors (Board) held two (2) public hearings on September 6, 2023 and September 13, 2023, respectively, at which time input from the public on the composition of the District wards including criteria for determining ward boundaries was invited and heard; and

WHEREAS, at the public hearings on September 6, 2023 and September 13, 2023, the Board considered all oral and written information, testimony, and comments received during the public review process, including information received at the public hearings and workshops, oral and written reports from District staff and the District's demographer, and all pertinent information prior to acting on, or making recommendations on, the ward election process and composition of maps; and

WHEREAS, at the public hearing on September 13, 2023, the Board provided initial direction to the demographer to begin drawing draft maps for a seven-ward election system; and

WHEREAS, based on public input and Board feedback, the District's demographer prepared six redistricting plans for review: Green, Blue, Purple, Red, Orange, and Yellow. These plans were made publicly available on the District's website on September 25, 2023, and the public was invited to comment on the plans as well as on the plans submitted by the public by the September 20, 2023 deadline; and

WHEREAS, at the public hearing on October 4, 2023, the Board considered all oral and written information, testimony, and comments received during the public review process, including information received at the public hearings and workshops, oral and written reports

from District staff and the District's demographer, maps, and all pertinent information prior to acting on, or making recommendations on, the content of the draft maps and the proposed timing and sequence of elections; and

WHEREAS, at the public hearing on October 4, 2023, the Board instructed its demographer to number the wards 1 through 7, north to south for all variations of the plans presented at the next meeting; address questions about sequencing at the next meeting in terms of which wards will come up for election in 2024 versus 2026; renumber the Green Plan as described above; prepare a variation of the Green Plan that includes Wards 1 through 5 and Wards 6 and 7 from the Red Plan; and prepare a variation of the Green Plan that splits the downtown area of Oakland into at least two and up to three wards and has flexibility as to potentially rotating through Emeryville/the Oakland Hills while maintaining the community of interest in East Oakland; and

WHEREAS, on October 16, 2023, consistent with the provisions of California Elections Code Section 10010, the District made publicly available on its website for review and comment an updated set of draft maps, respectively entitled, Pine, Apple, Emerald and Lemon; and

WHEREAS, at the public hearing on October 25, 2023, the Board considered all oral and written information, testimony, and comments received during the public review process, including information received at the public hearings and workshops, oral and written reports from District staff and the District's demographer, maps, and all pertinent information prior to acting on, or making recommendations on, the content of the draft maps and the proposed timing and sequence of elections; and

WHEREAS, at the public hearing on October 25, 2023, the Board of Directors directed the preparation of two ordinances for public comment and future consideration at the November 8, 2023 public hearing: one for the Pine Plan with two election sequencing options (one prioritizing Wards 1, 6 and 7 for the 2024 election, and another option prioritizing Wards 1, 2 and 6 for the 2024 election); and a second ordinance for the Revised Emerald Plan with two election sequencing options (one prioritizing Wards 1, 6 and 7 for the 2024 election, and another option prioritizing Wards 1, 2 and 6 for the 2024 election). In addition, the ordinances were to include language authorizing staff to make technical, non-substantive corrections and to correct a minor external boundary adjustment in Ward 4; and

WHEREAS, on October 27, 2023, consistent with the provisions of California Elections Code Section 10010, the District made publicly available on its website for review and comment updated draft maps, respectively entitled, Evergreen and Jade; and

WHEREAS, on November 8, 2023, the Board held its fifth and final public hearing, received public comment on two proposed ordinances (Ordinance 20 (Evergreen) and Ordinance 20 (Jade)), and introduced and waived reading of both ordinances; and

WHEREAS, the purpose of this Ordinance is to enact, pursuant to California Elections Code Section 10010, an ordinance providing for the election of Directors of the Board of

Directors of the Alameda-Contra Costa Transit District by-ward in seven wards to be created hereby.

NOW, THEREFORE, BE IT ENACTED BY THE BOARD OF DIRECTORS OF THE ALAMEDA-CONTRA COSTA TRANSIT DISTRICT:

<u>Section 1.</u> PURPOSE AND AUTHORITY.

The purpose of this Ordinance is to enact, pursuant to California Elections Code Section 10010, an ordinance providing for the election of members of the Board of Directors of the Alameda-Contra Costa Transit District by seven (7) single member wards. This Ordinance is adopted pursuant to the District's authority under California Elections Code Sections 10010, 10508, 10650 and Public Utilities Code Section 24823. The change in the method of electing members of the legislative body is being made in furtherance of the purposes of the California Voting Rights Act of 2001 (Chapter 1.5, commencing with Section 14025 of Division 14 of the California Elections Code).

Section 2. EFFECT OF ORDINANCE.

This Ordinance shall take effect thirty (30) days following its passage and adoption, and the text of the Ordinance (excluding exhibits which shall be made available at www.actransit.org/redistricting) shall be published after passage once a week for two consecutive weeks in a newspaper of general circulation within the Alameda-Contra Costa Transit District, with at least five days intervening between the respective publication dates not counting such publication dates.

Section 3. BY-WARD ELECTORAL SYSTEM FOR SEVEN DIRECTORS.

- (a) Pursuant to California Elections Code Sections 10010, 10508, and 10650, Directors shall be elected by-ward in seven (7) wards.
- (b) Except as provided in subdivision (c) hereof, the Director elected to represent a ward must live in that ward and be a registered voter in that ward, and any candidate for Director must live in, and be a registered voter in, the ward in which he or she seeks election at the time nomination papers are issued.
- (c) A Director in office at the time this ordinance takes effect shall continue in office until the expiration of the full term to which he or she was elected or appointed and until his or her successor is qualified. If vacancies in Director offices elected by-ward or at-large occur before the expiration of the full term thereof, such vacancies shall be filled according to law from the prior ward boundaries or District at-large, respectively.
- (d) Upon expiration of the full term of each Director elected at-large or by ward, that Director's successor shall be elected only on a by-ward basis in the wards established by this Ordinance. A vacancy in a Director office elected or appointed by-ward shall be filled according to law by a person qualified to hold the office, who lives, and is a registered voter, in the ward.

Section 4. WARDS.

Elections shall take place, and Directors shall be elected by wards, meaning one member of the ward shall be elected from each ward, by the voters of that ward alone. A copy of the adopted ward map and the metes and bounds for each of the seven wards are attached hereto as Exhibits A and B and are incorporated by reference.

Section 5. ELECTION SCHEDULE (OPTION 1)

- (a) Directors from Wards 1, 6 and 7 as so constituted shall be elected by ward beginning with the Statewide General Election in November 2024, and every four years thereafter.
- (b) Directors from Wards 2, 3, 4 and 5 as so constituted shall be elected by ward beginning at the Statewide General Election in November 2026, and every four years thereafter.

Section 5. ELECTION SCHEDULE (OPTION 2)

- (a) Directors from Wards 1, 2 and 6 as so constituted shall be elected by ward beginning with the Statewide General Election in November 2024, and every four years thereafter.
- (b) Directors from Wards 3, 4, 5 and 7 as so constituted shall be elected by ward beginning at the Statewide General Election in November 2026, and every four years thereafter.

Section 6. SEVERABILITY

If any section, subsection, sentence, clause or phrase of this Ordinance is for any reason held by a court of competent jurisdiction to be invalid, such a decision shall not affect the validity of the remaining portions of this Ordinance. The Board of Directors of the Alameda-Contra Costa Transit District hereby declares that it would have passed this Ordinance and each section or subsection, sentence, clause and phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses or phrases be declared invalid.

Section 7. MINOR CORRECTIONS

In case of an apparent conflict between the ward map attached to this Ordinance as Exhibit A and the ward metes and bounds in Exhibit B of this Ordinance, the ward map shall govern. The District Secretary is authorized to make technical adjustments to the ward boundaries specified in this section if necessary to facilitate the implementation of this Ordinance, so long as such adjustments do not materially affect the ward populations, the eligibility of ward candidates, or the residency of elected officials within any ward.



Re: CVRA – Ward Election Sequencing Proposals

Dear Counsel:

We are glad to hear that the AC Transit transition to a fully ward-based system pursuant to Resolution No. 23-033 ahead of the November 2024 general election has been proceeding smoothly and with active community engagement. We understand that the Board will be selecting a final map at its upcoming November 8, 2023 meeting and will also be deciding the issue of election sequencing.

We understand there are two potential sequencing proposals, and that in one plan, proposed Ward 2 would be up for election in 2024 and in the other proposed Ward 7 would be up in 2024. Under the Ward 2 plan there would be no vacant seat, but under the Ward 7 plan, the seat for the Ward 2 Director would potentially be vacant between the 2024 and 2026 elections.

The Board should proceed with the sequencing plan that results in a balanced, fully staffed Board. The sequencing plan that causes a vacancy leaves voters and residents in proposed Ward 2, where AC Transit ridership is high, without direct representation by an elected Director on the Board. A vacancy is not in the best interests of the voters and residents of AC Transit's jurisdiction, and it does not further the goals of the California Voting Rights Act ("CVRA"). We understand that it was suggested at a meeting that remedial districts must be sequenced first to meet the goals of the CVRA, *see* Elec. Code § 10010(b), favoring an election for proposed Ward 7 in 2024. While we appreciate the Board's concern for moving up an election in the proposed Ward with the highest proportion of Asian American voters, it is not our position that the Board's proposal to elect a Director from Ward 7 first at the expense of an elected representative for Ward 2 between 2024 and 2026 furthers the goals of the CVRA.
